## The 01/08/2024 Update incorporates the following enhancements/corrections:

This release incorporates several issues addressed by the USPS by republishing the January Mail Direction File and Labeling Lists. One of these issues was the redirection of ZIP codes 832 and 834 from the ASF Salt Lake City to the NDC Denver facility. These ZIP were corrected in a USPS republishing of the Mail Direction File, but our software has a hard redirect built in for many years.

A software change will be needed to allow these ZIP codes to be directed correctly. If you are mailing to ZIP code 832 or 834, **we recommend continuing to use the December tables** while we make the necessary software changes to accommodate the redirection.
