
Feature Updates

New ZIP+4 Search with Address Browser (F7)

The F7 function has been updated for Mail Manager and Mail Manager LE. This feature allows you to use the ZIP+4 database to search for possible address matches to help correct addresses that were not successfully encoded. Using the results of your search, you can manually update the record. The ZIP+4 database must be installed and active to use this feature.

NOTE This feature is not available with Remote Encoding.

With an open list, go to Postal > ZIP + 4 Encode > ZIP Code Search or press F7. The search results will appear in the window.



The upper-left pane displays:

- Original Address: The original address from the open list
- **Search Address**: The input for the search
- Result Address: The result of the search if the address is valid

NOTE: The address browser cannot indicate which addresses are deliverable according to DPV data, due to USPS regulations.

The upper-right pane displays a list of suggested valid data that is as close a match as possible to the address in the record.

The bottom pane displays valid address details and ranges for the selected data.
